Committee Reports:

Finance: Finance reports were displayed. The Cobras baseball team was paid for in FY2024. No changes were made.

Guest Speakers: Bill Heard was absent, so this item is tabled until August.

VFW-American Legion Facility Agreement: Mike reported that he is still working to obtain enough votes for approval within the VFW.

Next Fundraiser: Travis made a motion to accept our next fundraiser as a wine tasting. Doug seconded it, and it passed. Bill Marsh made a motion to donate proceeds from the wine tasting to the Wounded Warrior Project. Doug seconded it. After discussion, it was voted on and passed. The fundraiser will be on October 12 from 2 to 5 pm. Bill Marsh presented a list of tasks to be completed and it is attached. He said Total Wine will provide wine at 30% off. We must have two bottles of each wine (one for tasting and one for auction).

Scout Troop Sponsorship: Travis and Jonathan Owens have worked together to identify a local Boy Scout troop that the Post can sponsor. Travis reported they have identified Troop 271 in University City as needing a sponsor. He will check this out further before the next meeting.

New Business:

Budget Approval: Kent presented the FY 2025 proposed budget for the Post. After discussion of the number of boys we sponsor for Boys State it was agreed to keep it at three. Doug requested we add \$100 on line 16 for brochures to advertise the American Legion. Line 17 should reflect \$38.50. Travis made a motion to approve the budget with amendments. Bill Bartle seconded it, and it passed.

Future Investment Discussion: Our investments will be maturing and we need to find new instruments to invest in. Kent appointed an investment research committee to review possibilities and report back at the August meeting. The committee consists of Kent, Mike and Mark. Others with inputs can provide those to the committee.
